



**TAX LEVY ORDINANCE
ROAD DISTRICT**

An ordinance levying taxes for all road purposes for Dorr Road District, McHenry County, Illinois, for the tax year 2015, collectable in 2016.

BE IT ORDAINED by the Board of Trustees of Dorr Township, McHenry County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Dorr Road District on November 12th, 2015, does hereby determine and declare that the sum of one million, two hundred sixty-five thousand, one hundred twenty-two dollars (\$1,265,122) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as: Road District Fund, Permanent Hard Road Fund, for the year 2016.

SECTION 2: That the amount levied for each object and purpose shall be as follows:




SECTION 4: That the board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Dorr Road District.


