- 1. Roll Call of Town Board Members. (Note Public present: Sue Brokaw.)
- 2. Public Comments. None. Supervisor Pierce presents the plaque for Best Website (Mighty Message Contest) won by Dorr Township and received at the Annual Township Officials of Illinois Conference Awards Banquet.
- 3. Approval of Minutes of the October 14, 2014 meeting. Motion by Trustee Sheahan to approve the Minutes of the October 14, 2014 meeting of the Board. Motion seconded by Trustee Fuller. Motion passed unanimously.
