township website - we won in our population category. Wireless tower going up on 820 S. Valley Hill Road. Contacted Erin Anderegg (Sara Schacht Memorial Foundation) to obtain defibrillator; cost is \$1,095.00. Possible appointment of Deputy Clerk? Clerk Brenda Stack will advise.

Assessor: In the process of responding to the appeals - approximately **500** - down over 40%. 101 of the appeals from The Sanctuary in Bull Valley-vacant lots. Hearings beginning on October 30th through November. Residential Sales Entered September 10, 2014 to October 14, 2014 presented for review.

Highway Commissioner: Grant money waiting for 2 years finally arrived - \$75,000.00. Busy at the garage. Finished up the last round of mowing. Tree work on Lucas Road and some others. Hope to start shoulder work next week and get it done by the end of the month, then start servicing trucks getting ready for winter. Did order salt on September 15th; called three (3) times - they say they will call back but do not; will try State Rep. for possible assistance in persuasion. As discussed, cost of salt is real high - hopefully we won't have a bad winter.
