Highway Commissioner - Highway Commissioner Thurman advises he was involved in an accident on January 16, 2017 with the 2004 Sterling snowplow truck; bad weather - raining, freezing, ice. Truck was a total loss; slid off road and rolled on its side. TOIRMA valued the loss at \$34,000.00; check not yet received. We were left with three trucks in our fleet; totaled truck was the oldest in the fleet, as the new truck on order has not yet arrived. Concern over time of year and possible winter weather, a used truck became available a week after the accident. The truck cost more than insurance loss (an additional \$23,000.00) from Road District budget, but we sold mini excavator, so did not hurt the budget too badly. Had to act quickly because of time of year and risk of possibility of winter weather. This truck (2008 International) fit our needs and we were able to use some equipment off totaled truck. Paving bills came in, that is why Permanent Hard Road Fund is so high. No more salt needs to be ordered this season, or other material (beet juice, etc.).
