1. Roll Call of Town Board Members. Note Public present as indicated above.
2. Public Comments: None.
3. Approval of Minutes of the September 12, 2017 meeting.

Motion by Trustee Cantwell to approve the Minutes of the September 12, 2017 meeting of the Dorr Township Board. Motion seconded by Trustee Calvin. Motion approved unanimously.

5. Tax Levy - Road District

Levy held flat; same as last year. Brief review of Road District levy numbers. Will be on public view until November 9, 2017 meeting.

6. Tax Levy - Township

Small changes: Total was at \$669,000 - increased to \$670,000.00;
Public Assistance increased to \$25,000. Otherwise, same as last year.

Approval of Township and Road District levies at November meeting.

7. Reports:

Supervisor - Insurance premium- policy up for renewal December 1st. Premium going up 16%. We will have other options to consider.

Assessor - Residential Sales Entered September 13, 2017 - October 10, 2017 provided for review. Going through all the appeals that came in; approximately 200; gathered evidence/comparables and provided to the Board of Review. Hearings have started. Presentation with Steve Reich went okay; some public present voiced their discontent. Pretty large turnout. They will hold other meetings with other townships.

Highway Commissioner - Mowed for the last time; put in some more culverts; truck work completed before winter; inmate assistance this week. Property next door - Veronica assisted in obtaining comparables; closer to \$7,000 per acre instead of the \$10,000 per acre listed. Spoke with listing realtor; boring tests will not be done until/unless offer presented. Attorney Saladin advises Letter of Intent to broker if we want to make an offer. Short discussion regarding possible purchase of property.

Clerk - Certificate of Publication from the Woodstock Independent - Public Notice of Availability of Audit Report of Dorr Township dated September 20, 2017.

Trustees - Trustee Calvin asks about paving project. Highway Commissioner Fuller provides brief review.
