

**AN ORDINANCE ABATING A PORTION OF THE 2018 TAX LEVY OF  
DORR TOWNSHIP, McHENRY COUNTY, ILLINOIS**

**WHEREAS**, Dorr Township, McHenry County, Illinois, is a non-home rule unit of local government pursuant to Article VII, Section 8 of the 1970 Illinois Constitution; and

**WHEREAS**, Dorr Township, McHenry County, Illinois, did on December 11, 2018 adopt the Tax Levy Ordinance of Dorr Township, McHenry County, Illinois; and

**WHEREAS**, there is provided by the terms of said Ordinance, the imposition of a tax to be levied on taxable property within the limits of Dorr Township, McHenry County, Illinois, for the tax year 2018; and

**WHEREAS**, Dorr Township, McHenry County, Illinois, in order to provide tax relief for taxpayers for property within Dorr Township, McHenry County, Illinois, wishes to abate a portion of the tax levy imposed by Dorr Township, McHenry County, Illinois, for the tax year 2018;

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF DORR TOWNSHIP, McHENRY COUNTY, ILLINOIS, as follows:**


