



An ordinance levying taxes for all town purposes for Dorr Township, McHenry County, Illinois, for the tax year 2020, collectable in 2021.

BE IT ORDAINED by the Board of Trustees of Dorr Township, McHenry County, Illinois, as follows:

SECTION 1: That the sum of six hundred thousand dollars (\$600,000) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as: Town Fund, General Assistance, for the year 2020.

SECTION 2: That the amount levied for each object and purpose shall be as follows:



SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and affect after its adoption, as provided by law.
