Woodstock Rotary Club coordinating event, soccer fields across from the garage will be used for traffic control/staging. Check in/register - no contact; no one has to step outside of their cars so as to maintain safe distance. No paint; no fluorescents. Two (2) other concurrent events being held that date - one in Harvard and another one on the McHenry/Crystal Lake border; these two (2) County-sponsored events are subsidized by the State. We are utilizing a minority/female-run business, and keeping it local. Behr Recycling is also participating. There will be a fee for certain items - posted on township website, as well as Woodstock Rotary Club website. Trustee Cantwell states he is leaving the Dorr Township Board this cycle, and would like to have this event happen at least once a year. A reminder that if it plugs into the wall, we can take it. 8:00 a.m. start for volunteers. Ad/flyer good visibility for the Township and the Woodstock Rotary Club - added services to our community.
