

MINUTES OF THE  
PUBLIC HEARING ON DORR ROAD DISTRICT BUDGET  
June 8, 2021 at 6:45 p.m.

Meeting called to order at 6:45 p.m.

1. Pledge of Allegiance recited.
2. Roll Call of Board conducted; those present as listed.
3. Call of the Meeting on Dorr Road District Budget and Certificate of Publication.

**Motion by Supervisor Brokaw to dispense with the reading of the Call of the Meeting. Motion seconded by Trustee Buckley. Motion carries.**

Discussion. Supervisor Brokaw advises that at last month's Public Hearing on Dorr Township Road District Budget, those present did not feel comfortable approving the Road District Budget without the Highway Commissioner present. Any questions to direct to Highway Commissioner Fuller? Supervisor Brokaw asks for explanation of Capital Outlay of \$67,000.00. Highway Commissioner Fuller states that this is for equipment expecting replacement: chipper, roller, and stump grinder. Brief description of condition of these pieces of equipment and necessity/probability of requiring replacement; chipper being traded in for the purchase of the new one. Paving projects this year: South section of Dean Street between Lucas Road and Route 176; 400 foot patch on Pleasant Valley Road; Dorr Township section of Sunnyside Road. Peter Baker & Sons starting some time this week or next week. Our section of Haligus Road – spot to be done – Geske completed already. Striping not done; paint difficult to obtain. Whoever gets the paint first, that's who we will have do the striping. Replaced a lot of culverts. Trustee Buckley asks about the bid process – already allocated this year, voting on budget for next year. Process explained by Highway Commissioner Fuller.

**Motion by Trustee Buckley to approve and adopt the Tentative Budget and Appropriation Ordinance as and for the Budget and Appropriation Ordinance for the Dorr Road District in the amount of \$254,500 and the Permanent Hard Road Fund in the amount of \$992,500, for an aggregate total Budget of \$1,247,000 for the Fiscal Year April 1, 2021, ending March 31, 2022. Motion seconded by Trustee Cullotta. Board polled; motion carries.**
