



**TAX LEVY ORDINANCE
ROAD DISTRICT**

An ordinance levying taxes for all road purposes for Dorr Road District, McHenry County, Illinois, for the tax year 2021, collectable in 2022.

BE IT ORDAINED by the Board of Trustees of Dorr Township, McHenry County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Dorr Road District on November 9th, 2021, does hereby determine and declare that the sum of one million, three hundred forty-two thousand, four hundred five dollars (\$1,342,405) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as: Road District Fund, Permanent Hard Road Fund, for the year 2021.

SECTION 2: That the amount levied for each object and purpose shall be as follows:




SECTION 4: That the board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Dorr Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and affect after its adoption, as provided by law.
