WHEREAS, Dorr Township, McHenry County, Illinois, did on November 9, 2021 adopt the Tax Levy Ordinance of Dorr Township, McHenry County, Illinois; and

WHEREAS, there is provided by the terms of said Ordinance, the imposition of a tax to be levied on taxable property within the limits of Dorr Township, McHenry County, Illinois, for the tax year 2021; and

WHEREAS,, Dorr Township, McHenry County, Illinois, in order to provide tax relief for taxpayers for property within Dorr Township, McHenry County, Illinois, wishes to abate a portion of the tax levy imposed by Dorr Township, McHenry County, Illinois, for the tax year 2021;


