Meeting called to order by Supervisor Brokaw at 7:00 p.m.

Pledge of Allegiance recited.

- 1. Roll Call of Board Members present as listed above.
- 2. Public Comments: None
- 3. Approval of Minutes of the February 8, 2022 Board meeting.

Motion by Trustee Cullotta to approve the Minutes of February 8, 2022. Motion seconded by Trustee Calvin. Motion approved unanimously.

4. Approval of Claims for period February 9, 2022 to March 8, 2022:

Request for approval at this time with report at next month's meeting to show actual activity. Motion by Trustee Calvin to approve claims from March 9, 2022 to March 31, 2022. Motion seconded by Trustee Thurman. Motion approved unanimously.

General Assistance and Salvation Army case reports available for review.

5. Senior Activities Report

Written report from Laura Wassinger provided for review. Still working to get exercise classes here. Sue Brokaw advises she has contacted City of Woodstock personnel, and is waiting for response. Trustee Buckley advises his organization may be able to help; Supervisor Brokaw advises that would be great. Upcoming events briefly reviewed.

6. ComEd Energy Efficiency Program Discussion

Supervisor Brokaw provides Carey Electric quote for replacement of light fixtures. High cost because of prevailing wage. Rebate from ComEd is about \$3,400.00. Yearly savings with LED type fixtures would be about \$2,000.00 per year. Trustee Calvin states that would be 15 years to recoup investment; cost is \$240.00 per light fixture. Trustee Calvin suggests due to cost, we may want to revisit solar energy. Discussion continues. Supervisor Brokaw will do a little further research and report back to the Board.

 - 2. Line item 12436 -\$100.00 from Assessor Dues to Appraisal Services line item 12443. Motion by Trustee Buckley to approve; second by Trustee Calvin. Board polled; motion approved unanimously.
 - b. Road Fund
 - 1. Line items 34413 \$6,000.00 from Road Maintenance Replacement Tax Distribution to 31451 Replacement Tax Distribution. Motion by Trustee Thurman to approve; second by Trustee Calvin. Board poled; motion approved unanimously.

9. Abatement Ordinance - 2021

Brief review and discussion of levy process and current budget. Unanticipated Senior Program impact. Trustee Buckley asks if impact on inflation, etc. considered? Discussion continues. We have abated four (4) times in the last five (5) years; based each year on the previous year's amount. Any information on projected property tax impact? Assessor Benitez provides brief review of assessment process and anticipated outcome. Supervisor Brokaw advises it shouldn't hurt us to abate the \$40,000.00 proposed.

Motion by Trustee Buckley to approve the ordinance abating a portion of the 2021 tax levy in the amount of \$40,000.00. Motion seconded by Trustee Cullotta. Board polled; motion approved unanimously.

10. Town Fund Budget

Dorr Township Budget & Appropriation Ordinance reviewed. Capital Fund Account - \$500,000.00 committed to new buildings. Review of General Town Fund - actual and budgeted. Line item review. Increase in printing due to proposed new newsletter, and postage. Funds designated in Capital Fund again discussed. Discussion of new buildings; anticipated cost of project. Continued review of budget and certain line items. Trustee Cullotta asks how we are doing with the QuickBooks transition; Supervisor Brokaw advises okay. Breakout of funds a concern. Trustee Buckley asks if it would be of value to have someone come in and set it up? Trustee Calvin states he would like to see breakdown; Supervisor Brokaw advises that all bills are always brought in to each meeting, and they are available for review at any time.

11. Road District Budget

Capital Fund Account - \$350,000.00 committed to new buildings. Trustee Calvin asks about receipt of any pandemic relief funds; Supervisor Brokaw advises townships have not been a part of that program. Trustee Buckley advises the County has funds available; might be worth pursuing. Trustee Calvin asks if the solar energy project might fit under that suggestion. We would have to have numbers available for the project to proceed. Continued discussion and review.
