

**TAX LEVY ORDINANCE**

**DORR TOWNSHIP**

An ordinance levying taxes for all town purposes for Dorr Township, McHenry County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of Dorr Township, McHenry County, Illinois, as follows:

SECTION 1: That the sum of six hundred twenty-five thousand dollars (\$625,000) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as: Town Fund, General Assistance, for the year 2022.

SECTION 2: That the amount levied for each object and purpose shall be as follows:


