The project will consist of: Demolition of an existing building, concrete slab and foundation approximate 60×100 pole barn consisting of vehicle storage repair and office. Construction of 2 new 4,920 square foot Pre-Engineering buildings. 1 building includes offices, break room and 2 toilets rooms and vehicle maintenance. 1 building is for vehicle storage. The project includes, but not limited to, sitework, abandoning a well and new well, building sanitary to tie into the existing septic system, concrete, carpentry, awnings, plumbing, mechanical, electrical and finishes.

Project anticipated mobilization date is August 5, 2024.

A pre-bid meeting and site visit will be held July 9, 2024, at 9:00 am. The site visit will be held at the 12322 Davis Rd., Woodstock, IL address.

Work performed under this contract shall be in accordance with Illinois Prevailing Wage Act (820 ILCS 130/1, et seq.), the Substance Abuse Prevention on Public Works Projects Act (820 ILCS 265/1, et seq.), Drug Free Workplace Act (30 ILCS 580/1, et seq.), and any applicable superseding ordinance or public law.

A Bid Bond in the amount of Ten Percent (10%) of the total bid must be presented with the formal bid. Bid Bond shall be in the form of an approved insurance company Bid Bond or a Cashier's Bank Check issued to Owner.

For bids in excess of \$150,000, the successful bidder shall be required to provide a Performance Bond in the sum equal to One Hundred Percent (100%) of the amount of the bid, with sureties to be approved by the Owner. Said bond shall be conditioned upon proper and faithful performance by the Contractor of the Work specified in accordance with the plans and specifications and according to the time, terms, and conditions of the contract.

The Bid Form and any other documents required to be submitted with the Bid shall be attached to Bid **for each Bid Package**. The Bid shall be addressed to the party receiving the Bids and shall be identified with the Project name, the Bidder's name and address, and the Bid Package (designated portion of the work) for which the Bid is submitted.

Each bid shall include all elements of construction to furnish all labor, materials, equipment, applicable taxes, if any, and all other expense items to completely perform the work required. Bids will be held good and may not be withdrawn for a period of sixty (60) calendar days from the date of opening.

Bids shall be submitted no later than the date and time of the bid delivery deadline indicated above. The Bidder shall assume full responsibility for timely delivery to the location designated.

The Owner reserves the right to reject any or all Bids and to waive any irregularities and/or reject any or all bids when, in the Owner's opinion, such action will serve the best interest of Dorr Township. The Owner also reserves the right to cancel the bidding process before bid envelopes are opened.
