TAX LEVY ORDINANCE ROAD DISTRICT

An ordinance levying taxes for all road purposes for Dorr Road District, McHenry County, Illinois, for the tax year 2024, collectible in 2025.

BE IT ORDAINED by the Board of Trustees of Dorr Township, McHenry County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Dorr Road District on December 10th, 2024, does hereby determine and declare that the sum of one million, five hundred twenty-five thousand dollars (\$1,525,000) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as: Road District Fund, Permanent Hard Road Fund, for the year 2025.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
