TAX LEVY ORDINANCE

DORR TOWNSHIP

An ordinance levying taxes for all town purposes for Dorr Township, McHenry County, Illinois, for the tax year 2024, collectable in 2025.

BE IT ORDAINED by the Board of Trustees of Dorr Township, McHenry County, Illinois, as follows:

SECTION 1: That the sum of six hundred seventy-five thousand dollars (\$675,000) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as: Town Fund, General Assistance, for the year 2024.
