

MINUTES OF THE
PUBLIC HEARING ON DORR ROAD DISTRICT BUDGET
May 13, 2025 at 6:45 p.m.

Meeting called to order at 6:45 p.m.

1. Pledge of Allegiance previously recited at Town Fund Budget Public Hearing.
2. Roll Call of Board conducted; those present as listed.
3. Call of the Meeting on Dorr Road District Budget and Certificate of Publication.

Motion by Trustee John Buckley to dispense with the reading of the Call of the Meeting. Motion seconded by Supervisor Sue Brokaw. Motion carries.

Certificate of Publication presented.

4. Discussion. Highway Commissioner Fuller advises no changes since presented last month. Everything is close to last year, up a little in some things, but not much. Supervisor Brokaw asks what roads are being paved this year. Highway Commissioner Fuller advises Juanita Vista, Bunker, Hercules & Castle sections, and Beech. Should be done middle of July or end of July; Geske bid won. Supervisor Brokaw asks about \$200,000 Capital Outlay – Equipment. Highway Commissioner Fuller explains cost of trucks has gone way up; used some of last year’s budget for part of the truck, next year’s budget (2026) will include chassis, and the next year’s budget (2027) the rest of the truck will be included, with delivery expected in 2027. Trustee John Buckley suggests contacting incoming Nunda Township Highway Commissioner Ron Parrish, as he will be getting rid of excess equipment. Brief discussion.

Motion by Trustee John Buckley to approve and adopt the Tentative Budget and Appropriation Ordinance as and for the Budget and Appropriation Ordinance for the Dorr Road District, General Road Fund in the amount of \$476,700, and the Permanent Road Fund in the amount of \$2,202,000, for an aggregate total Budget of \$2,678,700 for the Fiscal Year April 1, 2025, ending March 31, 2026. Motion seconded by Trustee Laura Cullotta.
